WEIGHT	<ul> <li>*NO PUBLIC FUNDING TO PRIVATE, HOMESCHOOL, OR OTHER OUTSIDE SUPPORTS</li> <li>CTE as part of weighting (i.e., completers, industry certs) due to costs (equipment, transportation) and staffing challenges <ul> <li>The growing importance of CTE as a support/service which improves students' post-secondary, life and career outcomes;</li> <li>The importance of CTE as an input which supports the growth and quality of Tennessee's workforce and economy.</li> </ul> </li> <li>Emphasize consistency across the state</li> <li>CTE: <ul> <li>extended day</li> <li>Ensure new formula fully accounts for necessarily-smaller sizes of CTE classes</li> <li>Transportation costs</li> </ul> </li> <li>Work-based learning (i.e., coordinator, transportation, dedicated personnel)</li> <li>FINANCIAL LITERACY <ul> <li>Enhance financial literacy curriculum at middle school to:</li> <li>(avoid a gap in learning from lower grades and HS)</li> <li>enhance financial literacy's ability to support aligned middle-school student and parent career awareness and academic pathway decisions leading into high school.</li> </ul> </li> <li>FACILITIES (equity across the state to support upkeep)</li> <li>INCREASE OPPS FOR AP AND DUAL ENROLLMENT</li> </ul>
